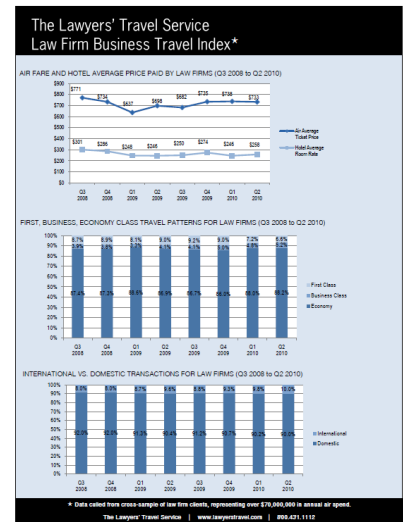
**THE LAWYERS' TRAVEL SERVICE RELEASES QUARTERLY LAW FIRM BUSINESS TRAVEL INDEX**  
*Index compares past eight quarters for law firm, financial services, and business clients.*

**New York, July 26, 2010** — The Lawyers' Travel Service, the 7th largest corporate travel management company by sales volume in the United States as ranked by *Business Travel News*, announced today that it has released its quarterly Law Firm Business Travel Index through the second quarter of 2010. The Law Firm Business Travel Index, which was launched in 2009, will continue to be updated quarterly going forward, with each release comparing the past eight quarters' travel patterns for law firms.

The Index illustrates the following statistics for the most recent eight quarters:

- Law firms average airfare price paid by quarter
- Law firms average hotel rate paid by quarter
- Law firms breakdown of the percentage first, business, and economy class tickets by quarter
- Law firms breakdown of the percentage domestic vs. international tickets by quarter

The Corporate Business Travel Index data is culled from a cross-industry-sample of clients, representing over \$100,000,000 in annual air spend.
